

Dexter Township Resolution # 19-551

A resolution to appoint Township personnel as Ordinance Enforcement Officer, in accordance with the provisions of Dexter Township Ordinance Number 28, the Ordinance Enforcement Officer Ordinance.

WHEREAS, Dexter Township has enacted various ordinances to protect the health, safety and welfare of citizens in Dexter Township; and

WHEREAS, Dexter Township ordinances provide penalties for violation of the ordinances; and

WHEREAS, The Dexter Township Ordinance Enforcement Officer Ordinance, Ordinance #28, Section II, states: *“The Township Board of the Township of Dexter is hereby authorized to appoint by resolution any person or persons to the office of Ordinance Enforcement Officer for such term or terms as may be designated in said resolution and for such compensation as the Board may determine.”*; and

WHEREAS, Absent such appointment, Dexter Township doesn't have any authority to enforce Township ordinances that don't contain specific provisions designating the person or persons responsible for enforcement:

NOW, THEREFORE, BE IT RESOLVED THAT the Dexter Township Board, by a vote of the majority at a regularly scheduled and duly noticed meeting held this 16th day of April, 2019, appoints the following persons/positions as Ordinance Enforcement Officer for the purposes of enforcing Dexter Township ordinances: Director of Zoning & Planning/Zoning Administrator; Zoning Officer/Code Enforcement Officer; and Township Supervisor; said appointments effective immediately and for terms ending when the position ceases to exist.


