

2014 Tax Information

Summer tax bills will be mailed out the first week of July and are due per Michigan Statute 211.44 by September 15th. In 2014, the last day to pay summer taxes without incurring any interest or penalty is Monday, September 15, 2014. After this date, one percent interest per month will be added to all unpaid tax bills unless a deferment has been granted per (MCL 211.905b(11) and 211.59). Winter tax bills will be mailed out the first week of December and are due per Michigan Statute 211.44 by February 16th. The last day taxes are due and payable before being turned over to the County as delinquent is Monday, March 2nd. In 2015, the last day to pay 2014 property taxes before they are returned as delinquent is Monday, March 2nd at 5:00 pm. Dexter Township will accept payment of 2014 property taxes up to and including Monday, March 2nd, 2015 **without** interest or penalty. After March 2, 2015, all unpaid real property taxes must be paid to the Washtenaw County Treasurer, P.O. Box 8645, Ann Arbor, Michigan, 48107 with additional interest and penalties as prescribed by law. Tax bills are mailed to the address of record as of June 1st and November 1st of each year. Should you not receive your tax bill, please contact the township office to confirm that we have your correct mailing address on file. Per Michigan Statute (MCL 211.44), failure to receive a tax bill does not abate late payments and penalties.

Tax payments may be made at the township office during normal business hours - 8:30 AM to 4:30 PM Monday through Friday, excluding holidays, the drop box located outside the township office, the Dexter branch of PNC Bank, by electronic check or credit card at 1-800-272-9829 or www.officialpayments.com, or by U.S. mail. Please note that **postmarks are not accepted** and allow for sufficient mailing time. Electronic check payments made via Official Payments Corporation are subject to a \$5.00 convenience fee for payments up to \$10,000.00 and \$20.00 for payments over \$10,000.00; credit card payments are subject to a 3% convenience fee. The Jurisdiction Code for Dexter Township is **3286**. **After Monday, February 16, 2015, payments cannot be accepted via Official Payments Corporation.** Upon receipt of your tax bill, partial payments may be made; however, any taxes unpaid by the statutory due dates will be subject to applicable interest and/or penalties.

The Township Treasurer is not responsible for any payments made on the wrong property and cannot transfer payment to or from any parcel or refund payments made on the wrong parcel.
